This in no way diminishes the outstanding commitment of many men -- and women --who are already involved. It just means that more men are needed and welcome!

Why we want men:

Executive Director At any given time our Volunteers in Protective Services (VIPS) program mentors 100 youth. Our current pool of mentors includes 66 women and 34 men. but we have 65 boys on our waiting list for mentors. Many have been referred to us because they need a male role model, and we want to match them with a male mentor.

In case there's any hesitation out there, I want to emphasize that it's easy to be a mentor!

- We provide comprehensive training and screening,
- Our outstanding professional staff provides ongoing support and supervision to every mentor.
- Mentors pick from the kids on the waiting list the one they want to mentor, usually based on background, geographic location and interests - sports, music, outdoor activities, etc.
- Mentors meet with the youth they are mentoring at mutually agreeable times
- We offer a variety of activities, such as holiday parties, trips to the Bronx zoo, and tickets to professional baseball, basketball and soccer games

One mentor, writer Tim Harper, says he knows why more men don't want to be a mentor. "I think they think it's hard, or that they will fail." But Harper found it easy and fun. He mentored a young boy for several years, doing fun things like teaching him how to ride a bike or taking him along on hikes with his own family.

Another fellow, the 11-year-old son of a friend, recently provided further insight. I was describing an ambi-

Bergen LEADS annually selects 30 people from diverse backgrounds to participate in a unique community leadership program; monthly seminars are held September-June.

Bergen LEADS to Host Debate on Regionalization

Bergen LEADS, the unique program designed to prepare the next generation of leaders, will host a public forum prior to graduation in June.

Monthly seminars led by former County Executive William "Pat" Schuber have been delving deeply into the critical issues that confront leaders in Bergen County. Shared services and regionalization have been themes that resonate in every issue -- whether healthcare, education, economic development, government, public safety or the increasingly broad diversity of our community.

Drawing on knowledge and experiences gleaned throughout the year, Bergen LEADS class members will debate "How can government best provide the appropriate level of needed services to residents in a time of very limited resources?"

Teams will examine the issue from three perspectives:

- 1. Eliminate County government and let individual municipalities provide services
- 2. Eliminate municipal government and let County government provide services
- Continue as is, with both County and municipal gov-3. ernments providing services, but make delivery of services more efficient and cost-effective.

Former Governor Thomas Kean has been asked to moderate the debate, which will be open to the public and will take place on either Tuesday, June 15 or June 22, at Bergen Community College.

tious home improvement project my husband was undertaking that I thought was too ambitious. Under his breath the boy commented, "You know us guys -- it's hard for us to give up our pride."

A couple of years ago I saw a great ad produced by the Ad Council. It showed a boy and a young man looking at a huge abstract painting. The boy asked "Do you know what it means?" The young man answered, "No." And then a halo appeared over his head. It so perfectly illustrated how easy it is to be a mentor. Just be yourself!

According to the Bureau of Labor Statistics, which tracks information about volunteering, of the 63-millionplus adults who volunteered in 2009, 58% are women and 42% are men, so that fact that men are in short supply as volunteers is not unique. But we want to do everything we can to reverse this trend and make men as welcome as possible!

Doing Good -- and Feeling Good!



Jesse Mautner is not your average high school student. While he's a sophomore at Pascack Hills High School, is a member of the Italian Club and of the school's baseball team, what sets Jesse apart is his dedication to helping others – and the steps he is taking to make a difference.

Every week he volunteers with The Bouncers, a local basketball team made up of special needs athletes who participate in the Special Olympics. He also volunteers with the Bergen

County Charity Classic, a baseball tournament that annually raises funds for charities and foundations of families associated with youth sports who have faced tragedy or illness.

Using his increasingly competent editorial skills, every month he researches, writes, designs and publishes a newsletter expressly for kids being mentored through the Volunteer Center of Bergen County's Volunteers in Protective Services (VIPS) program. VIPS helps kids who have suffered abuse, neglect or isolation, see and take steps to achieve a brighter future. Jesse selects topics and provides news, factoids, graphics, and fun notes to help pique interest and spark conversation between the mentors and the kids: sports, politics, movies, coming events, and – as a concession to the girls – even an article about the American Girl Doll.

"Writing the newsletter each month gives me a chance to use my skills to help improve the lives of other people," says Jesse. "I like the fact that what I am doing can make a difference. When you do these things you become a better person and leave an impact on others. With the basketball, I am able to teach other people the skills that I have. I love to see how happy they are when they learn a new skill and are actually able to use it."

P.E.A.L. Helps Shut-Ins

Phoning Elderly and Lonely (PEAL) is an initiative of our Retired & Senior Volunteer Program (RSVP) that links volunteers who are eager to provide friendly phone calls with others who are isolated in their homes.

"Usually those who are being called are shut-ins and are unable to get out because of illness or disability," says Barbara Wiederecht, RSVP Program Director. "But sometimes the caller is also a shut-in and is glad to make calls to others who are isolated and lonely. PEAL benefits people on both sides."

TEN AND COUNTING

This winter the Northern New Jersey Business Volunteer Council (BVC) celebrated ten successful years of providing leadership in employee volunteering. Since its launch in January of 2000, employee volunteers at more than 60 member companies have worked on behalf of low-income children and families, generating and distributing over \$1 million in resources.

- More than 4,000 foster children have been provided with backpacks filled with personal care items, socks, underwear and gifts.
- Approximately 13,000 pre-school children have received 65,000 new books to encourage love of reading and to foster literacy.
- The yearly "Tools for School" campaign has distributed nearly \$325,000 worth of school gear to youth-serving non-profit organizations and schools.
- An annual summer food drive has netted \$223,000 in food and grocery gift certificates distributed to low-income families who do not receive subsidized meals when school is not in session.

"Being successful in business is about more than doing well," says Sonja Clark, of United Water, who is current chair of the BVC. "It's also about doing good."

Our Mentoring Moms program matches trained and caring women volunteers as mentors to mothers who are overwhelmed by life's circumstances.

Feline wrote recently about her mentor, Lisa:

I think the most important thing is to feel like I have someone who doesn't judge my mistakes and I can talk to about anything. I love my mother very much, but Lisa gives me so much credit and support, my mom tries but it just doesn't seem to be as important than from Lisa. I also went into are (sp) relationship thinking she was perfect (perfect home, husband, kids, life). It felt REALLY good to see that other people struggle and don't have a perfect life. She was real with me and that made our relationship very strong. THANK YOU!

And this thrilling note from mentor Kim.

The past 6 months have been so hectic with T and her and the kids...doctors appointments, filing for financial aid, school, emergency room visits, therapy sessions. However, with all that said, 2010 has begun on a positive note for her...SHE PASSED HER GED!!!!! I am just so proud of her. She is now preparing to go for financial aid to begin Bergen Community College.

Our Volunteers in Protective Services program matches adult volunteers as mentors with children who have experienced abuse or neglect, helping them see and take steps to achieve a brighter future. "The children in the VIPS program rely on their mentors to believe in them, encourage them to laugh and to succeed," says VIPS program director Faith Samples-Smart. "We consider time spent with mentors as 'free' time—free of the challenges that have been hard for them to face daily in their environment.."
